## **Ohatchee Town Council Pre-Council Work Session December 18, 2018 5:30 pm**

Ohatchee Town Council met on Tuesday, December 18, 2018 at 5:30 pm at the Municipal Complex for a pre-council work session. Members present were Mayor Steven Baswell, Councilmembers Anthony Crosson, Perry Howard, Butch Mitchell and Teresa Lott. Councilmember Celesia Jennings was absent. Mayor Baswell declared a quorum present and the work session was called to order. There were no questions on the minutes from the work session or meeting held November 20, 2018 and there were no questions on the invoices presented for payment.

Due to a lack of items on the Agenda, Mayor Baswell began a discussion on road maintenance. Mayor felt the committee that will be checking on the roads after the first of the year should know a little history and his position on the Town's acceptance of the roads to maintain.

According to State Law there are several roads that the Town of Ohatchee is liable to maintain. Even with them being our responsibility, it should be done with the help from the County. There are numerous roads that should be the County's responsibility to maintain. There has never been an agreement reached between the Town of Ohatchee and Calhoun County about these roads. Mayor Baswell intends to stand by his decision to go by State law.

Mayor Baswell will be asking for approval to spend an amount no greater than \$5,000.00 for Anthony Brown to replace the flooring at old Town Hall. It is necessary to have this done before anyone injures themselves.

The work session was adjourned at 6:00 p.m.

Being there no further business to come before the Council, a Motion to Adjourn was made by Councilmember Perry Howard. Meeting adjourned at 6:10.
