Ohatchee Town Council met on Tuesday, April 21, 2020 at 5:30 pm at the Municipal Complex for a pre-council work session. Members present were Mayor Steven Baswell, Councilmembers Perry Howard, Butch Mitchell, Teresa Lott, Anthony Crosson and Celesia Jennings. There were no questions on the minutes from the work session or meeting held March 17, 2020 and there were no questions on the invoices presented for payment.

Mayor Baswell began a discussion on the Agenda items and what he will be asking for. The first item is to approve the purchase of a Speed Control Trailer for an amount not to exceed \$7200.00. The Trailer can be purchased from LESO Funds. The main purpose of having the trailer is so it can be used as a deterrent against speeding. The trailer can be moved around from place to place to ensure it is being used where we need it to be used. There were no questions on the purchase.

The second Agenda item is a write-in item. The Mayor will be asking Council to approve spending funds to repair the issues they are having at the Industrial Park Rd. with water. He is not sure what the cost will be to have the repairs done. Jerry Doss has done everything correctly as far as building the road but water is running along the seams. It comes down to it being a choice to spend the money repairing it or to write it off and be out all of the money we have spent to date. Council agreed that it would be pointless not to spend the money to repair it and wants to authorize the Mayor to spend up to \$40,000.00 on the repair.
