## **Ohatchee Town Council**

### **Pre-Council Work Session**

**May 19, 2020**

**5:30 pm**

Ohatchee Town Council met on Tuesday, May 19, 2020 at 5:30 pm at the Municipal Complex for a pre-council work session. Members present were Mayor Steven Baswell, Councilmembers Perry Howard, Butch Mitchell, Teresa Lott, Anthony Crosson and Celesia Jennings. There were no questions on the minutes from the work session or meeting held April 21, 2020 and there were no questions on the invoices presented for payment.

Mayor Baswell began a discussion on the Agenda items and what he will be asking for. The first item will be to adopt Resolution No. R-20-05-01 Authorizing participation in the Back to School Sales Tax Holiday. Mayor Baswell informed council that we have been participating for several years but this is the first time Alabama Department of Revenue has requested a copy of a Resolution passed before we can be listed on their website as participating. There were no questions on the Resolution.

The Mayor will be asking Council to approve spending additional funds to complete the Industrial Park Road. The cost was underestimated at the last meeting when the funds were authorized. There were no questions on the expenditure.

Invoices in the amount of \$9085.40 were presented for payment. Councilmember Butch Mitchell called for a motion to approve the payment of the invoices as presented. Councilmember Anthony Crosson seconded the motion. All voted aye. Motion passed.

Mayor Baswell called for a motion to adopt Resolution Number R-20-05-01 Authorizing participations in the Sales Tax Holiday. Councilmember Celesia Jennings made a Motion to adopt the Resolution, seconded by Butch Mitchell. All vote aye. Motion passed.

Mayor Baswell called for a motion to approve the request to spend additional funds to complete the repairs to Industrial Park Road at a cost not to exceed \$10,000.00. Councilmember Teresa Lott made a Motion to approve spending the funds, seconded by Celesia Jennings. All voted aye. Motion passed.

Being there was no further business to come before the Council, Mayor Baswell called for a Motion to Adjourn. Motion was made by Councilmember Teresa Lott, seconded by Butch Mitchell. The meeting was adjourned at 6:00 pm.
